



## Soaring Wings Half Marathon Expo 2019 Exhibitor Agreement

As an exhibitor in the Soaring Wings Half Marathon Expo, I agree to the following terms:

- No refunds will be made to exhibitors who fail to attend the Expo.
- All booth spaces must be paid in full at the time of request. Each booth space will receive a 6' skirted table, two chairs, and a trash can. Each booth will have an 8' high back drape and 3' high drape sides. Prices are as follows:
  - Single Booth: 10X10 feet at \$150
  - Double booth: 20X10 feet at \$250
  - Triple booth: 30X10 feet at \$400.
- Expo management retains the right to reject any exhibit.
- Exhibitors must have their booth manned at all times during the Expo hours
- There will be only one Company represented by each booth unless prior approval is given by Expo management.
- Booth assignment is made by the Soaring Wings Half Marathon Expo management team. If you have special requests, please make a note on your application. We will do our best to meet the needs of our exhibitors.
- Exhibitors grant permission for the Soaring Wings Half Marathon Expo management to take and use pictures of their booth for the purpose of promoting the Soaring Wings Half Marathon Expo.
- All exhibitors must conform to local fire department rules and regulations.
- Booth set up shall not extend beyond the assigned space, and must not block the view of or block the entrance of neighboring exhibitor space.
- Subletting a booth (partial or full) is not permissible.
- Soaring Wings Ranch, the Conway Regional Health and Fitness Center, or the City of Conway shall not be liable to exhibitors' agents, invitees, licensees, visitors, or to any other persons, or damage to persons or property on or about the premises caused by negligence or misconduct of Exhibitor, its agents, its employee, or any other person entering upon the premises under express or implied invitation of Exhibitor.
- Exhibitor agrees to indemnify and hold harmless the Soaring Wings Half Marathon, Soaring Wings Ranch, the Conway Regional Health and Fitness Center, or the City of Conway from any loss, attorney's fees, expenses, or claims arising out of any such damage or injury.
- Any use of the Soaring Wings Half Marathon logo/name or the Soaring Wings Ranch logo/name is prohibited without advanced written permission.
- All belongings of the exhibitor must be removed from the Conway Regional Health and Fitness Center within 2 hours after the close of the Expo on Friday, October 18, 2019.
- The Soaring Wings Half Marathon Expo management reserves the right to reject or restrict any exhibitor exhibiting inappropriate or offensive merchandise or behavior.

**Liability Information**

Exhibitor agrees not to deface property and agrees to accept liability for any damage to property of others or the Conway Health and Fitness Center. Any damages shall be remedied at Exhibitor's expense and to the satisfaction of the property owner. In the event of war, fire, terrorist attack, public catastrophe, strike, act of God, civil unrest, or other uncontrollable cause, the Expo or any part thereof is prevented from being held, or cancelled, the Soaring Wings Half Marathon shall, in its sole discretion, determine a refund, if any, to be paid to Exhibitors.

Exhibitor agrees to the Soaring Wings Half Marathon's promotional, non-commercial use of its images of its workers, agents, and staff in photographs, video, film, or other media depictions of the Expo. Exhibitor assumes all responsibility for loss, theft or destruction of goods, or personal injuries to itself, its employees, agents, representatives or visitors.
